





INSPECTION

Thoroughly inspect the shower base upon receipt, especially if the shipping carton is damaged, to insure it was not damaged during transit. If damage is discovered it must be noted on the bill of lading and a freight claim properly filed with the carrier. The installer is responsible for insuring that the unit is free from defects or damage before installation. In the event of a problem DO NOT install the unit.

Damage to the unit during installation is the responsibility of the installer. *ALL WARRANTY CLAIMS ON ACRYLIC SURFACE MUST BE MADE PRIOR TO INSTALLATION*. Inspect the base and accessories for missing or damaged components. Alert your distributor of any discrepancies.

INSTALLATION INSTRUCTIONS

Read all instructions carefully before beginning installation. Make sure base selected is the correct size for the installation and that a minimum six (6) inch diameter hole in the sub-floor or slab is in the proper location to coincide with the shower base drain.

- 1. Remove the stainless steel strainer from the drain assembly.
- Disassemble the locknut and two gaskets from the back of the drain assembly.
- 3. Apply a 1/4" bead of caulking (silicone) to the drain hole and insert the drain assembly.
- Replace the rubber washer, fiber washer, and locknut in that order.
- 5. Apply a lubricant (common household liquid soap works well) to the inside of the rubber seal of the drain assembly.

- 6. With the drain fitting passing over the center of the drainpipe, lower the shower base slowly into place, push down firmly until the base is in place and level in two directions.
- 7. The base should then be installed according to Figure 1, "TYPICAL CROSS SECTION VIEW".

CARE OF THE SHOWER BASE

Important: Make sure the base floor is protected with cardboard, etc. during installation to avoid damage to the acrylic surface.

Use a mild detergent to clean the acrylic surfaces of the base. Never use abrasive or grit type powder cleaners or pads, dulling of the acrylic surface will occur.

CLEANING

With minimum care, the acrylic surface of your shower base will retain its high luster finish for many years. For regular cleaning use a soft, wet cloth or sponge and a mild nonabrasive liquid detergent. Rinse the base thoroughly after cleaning.

SURFACE MAINTENANCE

Areas with minor scratches or dull surfaces can be restored by applying commercially available plastic polish (i.e. Novus Plastic Polish No. 2, available from your Jason Dealer), followed by an application of acrylic paste wax. Buff the surface with a clean soft cloth. Do not use sandpaper, steelwool, or abrasive rubbing compounds.

If scratches are too deep to rub out, or if the damage penetrates the acrylic surface, consult your dealer for recommendations on surface repair.

NOTE: These products conform to the "American National Standard for Plastic Shower Receptors and Shower Stalls", ANSI Z124.2-1995.

Written notice of warranty defects must be given to the company within thirty (30) days from the occurrence thereof. Written permission must be obtained by the retailer or distributor from the Company before any equipment claimed defective is returned for inspection.
